**Proposal to dispose balance stock of 328.85 tonnes of coal by eAuction dated 09.12.2024 from namchik Namphuk custodian Coal mines of NEC**

1. As approved by the competent authority, the balance quantity of 518.64 tones (rounded off to 550 tones to fit multiple of 50 tones as per CIL eauction scheme) of coal was offered for sale through eauction dated 23.10.2024 notified vide eauction notice no. M&S/eAuction/AUGUST2024/Namchik/1283 Date: - 17/10/2024 (Copy enclosed).
2. Out of 518.64 tones of Coal, 220 tones has been lifted, The current stock position of Namchik Namphuk custodian Coal mines of NEC as on 02.12.2024 are as follows:-

Therefore, in compliance with the directives of the Ministry of Coal, Government of India, vide letter No. F.No.110/1/2018/NA dated 28.05.2018 (Annexure-4, Page 1), and as approved by the competent authority vide N/s No.NEC/M&S/NamchikNamphuk/Disposal dated 14.03.2023, It is proposed to dispose the above balance stock of 328.85 tonnes of coal by eAuction dated 09.12.2024 with a 30% reserve price.

4. Since as per CIL notice No. CIL/M&S/SWMA/309 dated:25.11.2024 all coal companies of CIL including NEC will have to conduct eauction as per modified eauction scheme w.e.f 01.12.2024 through the MSTC Ltd and Mjunction Ltd till further advise, it is proposed to conduct the above auction on 09.12.2024 through Mjunction Ltd as per work order no. CIL/M&S/E-auction/1304 dated:14.11.2024 issued by CIL.
5. Since as per clause 3.2 of CIL eauction scheme, the minimum bid quantity by Road mode shall be 50 tonnes and bid increment in quantity shall also be in the multiple of 50 tonnes, the above quantity will be rounded up to 350 tones for auction. However actual quantity to be dispatch will be only 328.85 tones.
